## General Trends










#### Dynamic of Patents Filed in 2019-2023

#### Dynamics of Registration in 2019-2023












#### Dynamics of Applications Filed in 2019–2023




## Dynamics of Applications Filed under the National Procedure in 2019-2023



## Applications (under the National Procedure) by Country of Origin in 2023




## Dynamics of Registrations under the National Procedure in 2019-2023







## Activity of Residents and Non-residents-Applicants in 2023












